

CRWA Hays/Caldwell Water Treatment Plant Improvements Project Phase 2 Advertisement

Canyon Regional Water Authority (Owner) is soliciting bids for furnishing all labor, materials, tools and equipment and performing all work required for the Hays/Caldwell Water Treatment Plant Improvements Project Phase 2 through the Competitive Sealed Proposal process. The project consists of the construction of an ozone system, related components and appurtenances, yard piping, and associated structural, building mechanical, electrical, instrumentation, control, and site civil improvements.

This contract is contingent upon the release of funds from the Texas Water Development Board (TWDB). Any contract(s) awarded under this Invitation for Proposals is/are subject to the United States Iron and Steel (US I&S) requirements of Texas Water Code §17.183 and/or Texas Government Code, Chapter 2252, Subchapter F, as amended by SB 1289, 85th Legislative Session, as applicable.

Separate sealed Competitive proposals addressed to Canyon Regional Water Authority will be received until Friday, January 10, 2025 at 2:00 PM at Canyon Regional Water Authority's office located at, 850 Lakeside Pass, Suite 100, New Braunfels, Texas 78130 at which time they will be publicly opened and read aloud. A Mandatory Pre-Proposal Conference will be held at 2:00 PM on Thursday, December 5, 2024 at the Canyon Regional Water Authority Administration Building located on 850 Lakeside Pass, New Braunfels, TX 78130. A site visit will be held after the pre-proposal conference at 135 Old Martindale Rd, San Marcos, TX 78666. All inquiries about the meaning or intent of the Proposal Documents must be posted on Civcast on or before 2:00 PM on Thursday, January 2, 2025.

General Bond Requirements - Each bidder shall furnish a bid guarantee equivalent to five percent of the bid price (Water Code §17.183). Performance and payment bonds shall be in a penal sum of not less than 100 percent of the contract prices and remain in effect for one year beyond the date of approval. The bidder shall utilize a surety company authorized to do business in Texas in accordance with Surety Bonds and Related Instruments, Chapter 3502 of the Insurance Code.

Canyon Regional Water Authority reserves the rights to reject any and all bids and to waive any informalities in bids received; to eliminate a portion of the work or add additional work as required to keep the total contract amount within the funds budgeted; to award any parts of combination of parts of the project it deems necessary; and any other rights established under the laws of the State of Texas.
